07/31/08 TD:2515' PBTD:2450' Drill 7.875" hole to 2515'. Run 40 jts. 5.50" 15.50# J-55 LT&C casing, set @ 2512'. Cement first stage with 180 sks Type V, 5#/sk gilsonite, 1/4#/sk flocele. Cement second stage with 100 sks 50/50 neat cement, tailed by 350 sks 65/35, 2% CaCl2, 10#/sk gilsonite, 1/2#/sk flocele (1080 cu.ft.). Circulate 15 bbls cement to surface from first stage and 50 bbls cement from second stage. Plug down @ 10:15 pm on 08/01/08. Rig released on 08/01/08. Will test production casing during completion.
