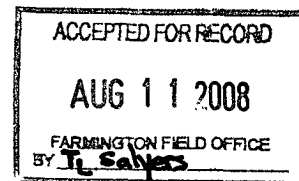

Drilled 6 1/4" hole to 3,792' TMD on 6/22/08. Underreamed hole to 11" from 3,470' to 3,792'. Utilized natural and air assisted surges to remove near wellbore material. On 7/29/08, set 10 jts of 5 1/2", J-55, 15.5#, LT&C Liner, run to 3,791' with 0 sx of cement. Top of liner hanger is at 3,354'. Perforations are from 3,493' - 3,778', 4 SPF, 0.52", 308 holes, 120 degree phasing. On 7/30/08 ran in hole with 118 jts of 2 3/8" tubing J-55, 4.7#, LT&C, end of tubing set at 3,765'. ✓
