Pumped in 173sx (221cf-39bbl) Type III w/2% CACL & .25pps Cellphane Flakes. Dropped plug & displaced w/14 bbl of H2O. Circ 20bbl cmt back to Surface. RD cementers 21:00hrs 07/20/08.
