Energen proposes to temporarily abandon the subject well and convert it into a pressure observation well. All current production equipment will be removed and packer at the end of tubing will be installed within 50 ft of the top perforations. Fruitland Coal perforation at 4166-4193 ft. A pressure test to 500 psig for 30 minutes will be performed to verify casing mechanical integrity. Periodic pressure tests will be performed as required. A profile nipple and blanking plug will run to shut-in the well.
