Cmted 2nd stage w/lead 660 sx (1914 cf) type G cmt w/3% econolite, 10# Gilsonite, 0.125# polyflake, & tailed w/100 sx (140 cf) 50/50 POZ cmt. Circ 40 bbis cmt to surface. On 9/2/08, pressure tested 7" csg to 1000 psi - OK. ✓
