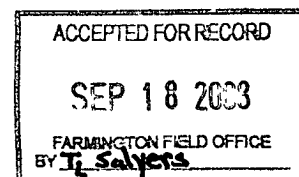

Drilled 8 3/4" hole to 4,080' on 9/3/08, set 93 jts of 7", J-55 LT&C, 23# casing at 4,079' with an ACP at 2,841' and HYD DV Tool at 2,839'. Cemented 1st stage w/210 sx (54 bbls) 50/50 POZ cement w/3% Gel, 0.6% Halad-9, 0.1% CFR-3, 5#/sx Gilsonite, 0.125#/sx Poly-E-Flake, TOR for 1st stage is at DV tool 2,839'. Cement 2nd stage w/590 sx (152 bbls) 50/50 POZ w/3% Gel, 0.6% Halad-9, 0.1% CFR-3, 5#/sx Gilsonite, 0.25#/sx Flocele. Circulated 30 bbls of cement to surface. Tested casing to 1,500 psi, held ok.
