08/01/08 - RU Halliburton. Frac FRC perfs with 56,743 gals 70Q slickwater foam & 5,000# 40/70 sand & 23,300# 20/40 sand.

08/02-25/08 - Flow back frac.

08/26/08 - TIH and clean out with air mist to PBTD @ 1650'.

09/02/08 - TIH with 2.375" 4.7# J-55 tubing, set @ 1538'. ND BOP. NUWH. TIH with pump and rods. Pressure test to 500 psi - ok.
