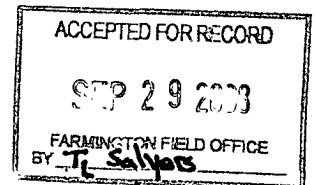

Cement with 150 sks 65/35 poz, 2% CaCl2, 10#/sk gilsonite, 1/4#/sk flocele tailed with 125 sks Class G, 2% CaCl2, 1/4#/sk flocele (443 cu.ft.). Plug down @ 10:37 am on 08/29/08. Circulate 28 bbls cement to surface. Rig released @ 5:00 pm on 08/29/08. Production casing will be tested during completion.
