Drilled 8 3/4" hole to 4,324' on 8/22/08, set 99 jts of 7", J-55 LT&C, 23# casing at 4,324' with ACP at 2,930' and Hyd DV Tool at 2,928'. Cemented 1st stage with 210 sx (54 bbls) 50/50 POZ w/3% Gel, 0.6% Halad-9, 0.1% CFR-3, 5#/sx Gilsonite, 0.125#/sx Poly-E-Flake. TOC for stage 1 is at DV tool @ 2,928'. After bottoms up circulated 5 bbls cement to pit. Cement 2nd stage with 590 sx (152 bbls) 50/50 POZ w/3% Gel, 0.6% Halad-9, 0.1% CFR-3, 5#/sx Gilsonite 0.25#/sx Flocele. Circulated 30 bbls of cement to surface. Tested casing to 1,500 psi, held ok.
