Plug to Abandon

Closed-Loop Design Plan:

Dugan Production proposes to use a closed loop circulating system to contain well bore fluid and cement generated during the plugging to abandon procedure on the subject well. The system will not entail any drying pad, temporary pit, below grade tank or sump. The system will consist of an above ground tank with adequate volume to hold all fluid generated during the operation.

1. Fencing is not required for an above ground closed-loop system.
2. Signage in compliance with 19.15.3.103 NMAC will be present.
3. Water will be contained in a water truck and not stored on location.

Closed-Loop Operating and Maintenance Plan:

The subject closed-loop system will be operated and maintained to contain liquids and solids in order to prevent contamination of fresh water sources, and to protect public health and the environment. To ensure that the operation is maintained, the following steps will be followed:

1. The fluids will be vacuumed out and disposed of at the Dugan Production operated Sanchez O'Brien 1 SWD (permit SWD-694) located 1650' fsl and 990' fwl L-Sec.6-Twn.24N-Rng.9W. Solids in the closed loop system will be vacuumed out and disposed of at either the Envirotech facility (permit NM-01-0011) located in Sec.6-Twn.26N-Rng.10W or the IEI facility (permit NM-01-0010B) located in Sec.2-Twn.29N-Rng.12W.
2. No hazardous waste, miscellaneous solid waste or debris will be discharged into or stored in the tank. Only fluids or cuttings used or generated by operations associated with this procedure will be placed or stored in the tank.
3. The division district office will be notified within 48 hours of the discovery of compromised integrity of the closed-loop tank. Upon the discovery of the compromised tank, repairs will begin immediately.
4. All the above operations will be inspected daily and a log will be signed and dated.

Closed-Loop Closure Plan:

The closed-loop tank will be closed in accordance with 19.15.17.13. This will be done by transporting cuttings and all remaining material to the Envirotech facility (permit NM-01-0011) located in Sec.6-Twn.26N-Rng.10W or the IEI facility (permit NM-01-0010B) located in Sec.2-Twn.29N-Rng.12W. All remaining liquids will be transported and disposed of at the Dugan Production operated Sanchez O'Brien 1 SWD (permit SWD-694) located 1650' fsl and 990' fwl L-Sec.6-Twn.24N-Rng.9W.
