In preparing this well to be plugged back to the Pictured Cliffs formation approximately 200 Bbl oil were swabbed. Therefore Richardson proposes testing this well for 60 days to determine productive potential. Upon succesful results the well will remain on production in the NW Cha Cha Unit.

If tests are not successful the well will be plugged back per previously approved procedures.
