Elm Ridge Exploration Co LLC has reached a TD of 1456' on October 12, 2008. We then ran 36 joints of 5 1/2" 15.5# J-55 casing down a 7 7/8" hole on October 13, 2008. Casing landed at 1416'. On October 13, 2008, We pumped the Lead slurry of 150 sks of STD cement with 6% gel, 2% calc, 5# gilsonite and 1/4# superflake, followed by a Tail Slurry consisting of 140 sks of STD cement with 2% calc, 5# gilsonite and 1/4# superflake. Circulated 17 bbls of good cement to pit. Pressure tested well to 1500 PSI for 30 plus minutes, tested ok. BLM was notified of operations but not present to witness. Rig down and moved off of location on October 14, 2008.
