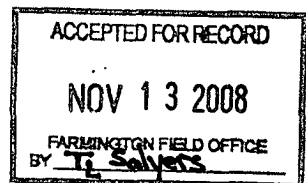

Elm Ridge Exploration Co LLC has reached a TD of 1415' on November 11, 2008, we then ran 33 joints of 5 1/2" 15.5# K-55 casing down a 7 7/8" hole to 1405' LEAD cement: pumped 175 sks of 65/35/STD/POZ cement w/ 2 6% gel, 5# gilsonite and 1/4# superflake, TAILED in with 160 sks of STD Cement w/ 2% calc, 5# gilsonite and 1/4# su Recovered 12 bbl of good cement to surface. Pressure tested well to 1500 PSI for 30 plus minutes. tested good. BLN was notified of operations, but not present to witness job. ✓
