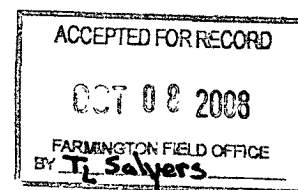

Elm Ridge Exploration Co LLC, has spud the above well on September 24, 2008. We drilled a 12 1/4" hole to 137'. On September 25, 2008 we ran 3 joints of 8 5/8" 24# J-55 casing to 132' and pumped 120 sks of STD cement with 2% calc and 1/4# celloflake. Circulated 7 bbls of good cement to pit. Pressure tested well to 1500 PSI. well tested good. BLM was notified of spud and surface casing job, but was not present to witness.
