- 1) Pressure test casing to 600 psi.
- 2) TOH w/ 2-3/8" tubing (currently set at 2850').
- 3) TIH & drill out CIBP at 2870'.
- 4) Clean out to PBTD at 3132'.
- 5) TIH w/tbg and set at bottom perforation.
- 6) Run pump and rods.
- 7) Return to production.



Well plan to return this well to production as soon as possible after the Forest Closure ends on April 1, 2004.
