10/27/2003 Spud 8 3/4" surface hole and drilled to 140'. Ran 3 jts (127.75') of 7", 23#, J-55, LT&C casing and landed at 133' KB. Cemented with 75 sx (89 cu.ft.) of Cl "B" with 3% CaCl<sub>2</sub> and 1/4#/sk celloflake. Circulated 5 bbls of good cement to surface.

11/1/2003 TD hole at 2030' with bit #3 (6 1/4", HTC, H117). Ran 47 jts (2007.17') of 4 1/2", 10.5#, J-55, ST&C and landed 2013' KB. Cemented 220 sx (460 cu.ft.) of Cl "B" 2% econolite cement w/ 1/4#/sk celoflake and 5#/sk gilsonite, followed by 100 sx (123 cu.ft.) of Cl "B" w/ 1/4#/sk celloflake and 5#/sk gilsonite. Circulated 35 bbls of good cement to surface.
