Elm Ridge Exploration Co LLC has spud the above well as of 11-23-08, we drilled a 12 1/4" hole to 411'. On 12-12-08 ran 10 joints of 8 5/8" 24# J-55 casing to 406' we then pumped 400 sks of Type G cement with 2% calcium chloride & 1/8# of polyflake, circulated 5 bbls of good cement to surface. Pressure tested well to 1500 PSI for 30 plus minutes, tested good. The BLM was notified of intent to spud, run surface casing and cement, but was not present to witness Rig down Rig and move off of location on 12-13-08, we will come back to TD later.
