Drilled out cmt, DV tool & 20' of shoe joint. On 10/8/08, PT 7" csg, DV tool, & sq perfs to 500 psi for 15 min - OK. On 10/9/08, ran CBL & found TOC @ 3370' (above the sq holes) and @ surface csg shoe above the DV tool. ✓
