The Jicarilla 117E #5C TD will be deepened from the APD to 8100'TVD. This will allow logs to be run throughout the Mancos Shale. The 4 1/2" 11.6 ppg J-55 casing will be run as a liner from 4000'-8100'. Cement will continue to be 50/50 Poz/"G" with 2% Bentonite, 0.5% Halad-9, 0.1% CFR-3, 5pps Gilsonite and 0.25 pps Floccle (13.5 ppg, 1.3 ft3/sx). Cement volume will be calculated off of caliper log with 20% excess.

The Mancos will not be completed but may be used in the future.
