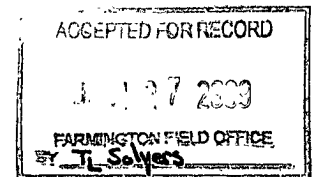

01/08/09 Drill 8.75" hole to 4080'. Run 99 jts. 7.0" 23# J-55 LT&C intermediate casing, set @ 4076'. RU Halliburton. Cement first stage with 175 sks Class G, 5#/sk gilsonite, 1/4#/sk floeale (213 cu.ft.). Circulate 20 bbls cement to surface. Plug down @ 4:00 am on 01/08/09. Circulate between stages. Cement second stage with 545 sks Class G, 2% CaCl2, 10#/sk gilsonite, 1/4#/sk floeale tailed by 75 sks Class G, 2% CaCl2, 10#/sk gilsonite (1156 cu.ft.). Circulate 25 bbls cement to surface. Plug down @ 10:15 am on 01/09/09. WOC. RD Halliburton. NU BOP. Test casing & BOP to 1200 psi for 30 minutes - ok.
