Pressure test BOPE and Casing to 2000 psi for 30 minutes - ok.
Drill 8 3/4" hole to 4185'. Ran 102 jts 7" 20# J-55 STC csg, 4173' set at 4185', Float collar at 4139' KB and DV at 2072' KB.

Stage 1: 190 sks (392 cf) 35/65 POZ/G + 6% Gel + 5 lbs/sk Gilsonite + 1/8 lb/sk Pol-E-Flake + 3% KCL mixed at 12.1 ppg, yield 2.076 cf/sk & 145 sks (184 cf) class G + 5 lbs/sk Gilsonite + 1/8 lb/sk Pol-E-Flake + 3% KCL mixed at 15.2 ppg, yield 1.269 cf/sk. Circ 20 bbl cmt off of DV to Surf. ✓
Stage 2: 272 sks (510 cf) 35/65 POZ/G + 6% Gel + 10 lbs/sk Gilsonite + 1/8 lbs/sk Pol-E-Flake + 3% KCL mixed at 12.5 ppg, yield 1.877 cf/sk & 50 sks (63 cf) class G + 5 lbs/sk Gilsonite + 1/8 lbs/sk Pol-E-Flake + 3% KCL mixed at 15.2 ppg, yield 1.269 cf/sk. Circ 10 bbl cmt to surf. ✓
