Spud 12 1/4" Hole at 1:00 pm, 7/10/08. Drill to 329'. Ran 8 jts 9 5/8" 36# J-55 STC casing, 321', set at 334' KB.

Cement with 200sx (236 cf) Type V cmt + 2% CaCl2 + 1/4 #/sk cellophane flake mixed at 15.6 #/gal yield 1.18. Circulated 12 bbls cmt to surface.

Pressure test BOPE and Casing to 600 psi for 30 minutes - ok. ✓

Drill 8 3/4" hole to 4130'. Ran 70 jts 7" 23# J-55 LTC csg & Ran 39 jts 7" 20# J-55 STC csg, 4112' set at 4124' KB, Float collar at 4078' KB and DV at 2364' KB.

Cemented as follows:

Stage 1: 125 sks (260 cf) 35/65 POZ/G + 6% Gel + 5 lbs/sk Gilsonite + 1/8 lb/sk Poly-E-Flake + 3% KCL mixed at 12.1 ppg, yield 2.076 cf/sk & 145 sks (184 cf) class G + 5 lbs/sk Gilsonite + 1/8 lb/sk Poly-E-Flake + 3% KCL mixed at 15.2 ppg, yield 1.269 cf/sk. Circ 20 bbl cmt off of DV to Surf. ✓

Stage 2: 370 sks (695 cf) 35/65 POZ/G + 6% Gel + 10 lbs/sk Gilsonite + 1/8 lbs/sk Poly-E-Flake + 3% KCL mixed at 12.5 ppg, yield 1.877 cf/sk & 50 sks (63 cf) class G + 5 lbs/sk Gilsonite + 1/8 lbs/sk Poly-E-Flake + 3% KCL mixed at 15.2 ppg, yield 1.269 cf/sk. Circ 25 bbl cmt to surf. ✓

Pressure test: BOPE & casing to 2000 psi - ok.
