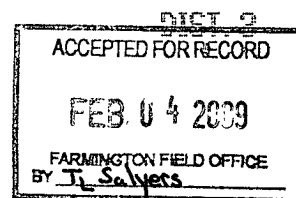

Top of liner set at 3860' KB; 125' overlap, 7" csg at 3985'. Cemented with 265 sks (350 cf) 50/50 Poz G + 2% gel + 5 lbs/sk Gilsonite + 3% KCL + 1/8 lbs/sk Poly-E-Flake + 0.4% HR9 + 0.2% HR5 mixed at 13.5 ppg, yield 1.32 cf/sk.

Circ 17 bbl cmt off of liner top to surf. Pressure test casing to 3000 psi, For 30 min, ok per operator
