07/25/08 - TIH and set CIBP @ 6070'. Pressure test casing to 500 psi - ok. Circulate hole clean.

07/28/08 - Pump 12 sks of Class G cement (50% excess) to cover the top of the Dakota f/6050' - 6150'. TOH with tubing to 5214'. Pump 12 sks Class G cement (50% excess) to cover the top of the Gallup f/5105' - 5205'. TOH with tubing to 2456'. Pump 12 sks Class G cement (50% excess) to cover the top of the Mesaverde f/2449' - 2349'.

07/29/08 - TIH and tag top of cement @ 2435'. Circulate well. Pump 12 sks Class G to cover the top of the Mesaverde f/2449' - 2349'. TOH with 2.375" tubing. Secure well.
