13. Describe Proposed or Completed Operations

Calls were placed to the BLM (Troy Saylers) and OCD (Kelly Roberts) on 2/18/09 to inform the agencies that the production casing was removed on this well for reuse on another well. The intermediate casing setting depth was @ 5011' and a CBL was run and the TOC was @ 3150' (1800+ overlap). A free point was used to determine where the free pipe started and the casing was cut @ 2900'. This 2900' of casing will be used in future new drill casing operations. Saving money was the motive for this action. Both the BLM and OCD recorded this activity for their records. The Production casing is now a cemented liner instead of full string of casing.
