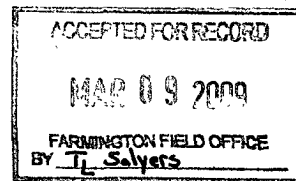

Test BOP 250 psi low, 2000 psi high - 15 minutes - ok. Test casing to 750 psi - 30 minutes - ok.
