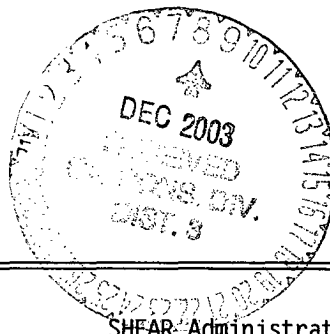

Circ. 17 bbls good cement to surface. WOC. NU BOP & WH. PT BOP. WOC. PT casing to 1000 psi for 30 minutes. Good test.
