Verbal approval was given 3/3/09 by Wayne Townsend (BLM) and Kelly Roberts (OCD) to change the surface casing design from 12-1/4" hole to 8-3/4" with the surface casing changed from 9-5/8" to 7" 20#, J-55. We should have also mentioned that the production hole would also be different. We are using a 6-1/4" bit instead of 7-7/8" bit, but the casing will size for the production casing will remain as permitted, 4-1/2" 11.6#, L-80 casing.

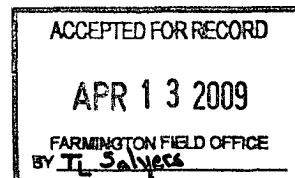
