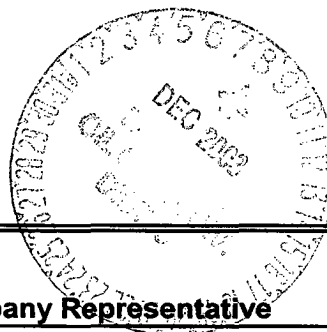

Devon energy requests an extension on the Big Game Deadline for the subject wel.. The well has started making 50 bbls of fluid per day. In order to cut down on the amount of water truck traffic in the area through the closure season we would like to move a workover rig on location and run tests on the Dakota formation to identify the source of the fluid entry. We will then take measures necessary to eliminate the fluid from entering the wellbore. All work will be approved through the BLM before commencing. We request an extention until December the 15th.
