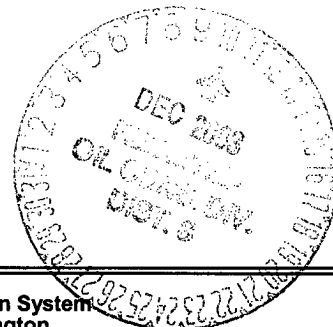

Tail w/60 sx Class "B" neat w/1/4# celloflake/sx (325 cu ft total cement). Displace w/43 H2O. Plug down @ 1730 hrs. Circ 10 bbls cement.
