Tail - 180 sx (239 cf - 42 bbl slurry) STD 50/50 POZ, 2% Bentonite, 6#/sx Pheno-seal. Dropped plug and displaced w/120 bbls water. Bumped plug w/1550 psi. Circ. 63 bbls good cement to surface. ND BOP, set slips and cut off casing. NU B-section, PT-OK. NU BOP. WOC. PT BOP, rams, manifold - OK. PT casing to 1800 psi for 30 minutes. Good test.
