Pumped a preflush of 30 bbls FW w/dye in last 10 bbls. Pumped 150 sx (174 cf - 31 bbls slurry) Class G cement w/2% CaCl₂, .25#/sx Cellophane. Released wiper plug and displaced w/15 bbls FW. Bumped plug w/1200 psi @ 0715 hrs 11/22/03. Circ. 15 bbls good cement. WOC. NU WH & BOP. PT casing, rams, lines and manifold to 250 psi for 3 minutes and then 1000 psi for 30 minutes. Good test.
