On 8/30/06, Devon started milling on the 4-1/2" CIBP between the DK & MV perfs @ 6360'. Milled & pushed plug to at least 6415'. On 9/5/06, it was discovered that the drill string had twisted or burned off leaving the mill & 7 jts of 2-7/8" tbg (217') in the hole above the CIBP. Original top of fish @ 6247'. Efforts were made from 9/6/06 through 1/5/07 to fish & mill the junk out. On 1/3/07, with the top of fish @ 6562', the returns had increased to 100% formation (shale). The 4-1/2" csg has several very tight spots between 6300'-6400'. On 1/5/07, a CCL logging tool was also lost in the hole. On 1/8/07, it was decided to complete the well as a single MV.
