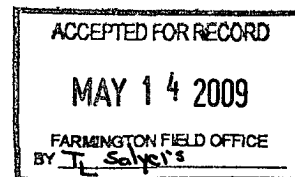
The casing on the Jicarilla 117E #5C was repaired as follows:

5/01/09 - Shot perforations in 7" casing @ 2284'. Attempted to pump into and circulate to surface. Not successful. NU 7" Retainer, TIH @ 2133'. Pumped 162 sks cement. TOOH.

5/04/09 - Tag cement @ 2130. Drill out retainer.

5/05/09 - Finish drilling out retainer. Test Squeeze to 750#. Test OK. *need time length of test*

5/06/09 - Run CBL f/ 1400-2400. Found TOC @ 1910'. Casing on still vacuum. Will be monitored per BLM. ✓
