23 Wells on 8 Gathering Systems
Operated by Dugan Production Corp.

Dear Mr. Fesmire, Mr. Henke and Mr. Lyons,

We are writing to advise that Dugan Production is planning to replace the Barton Dry Flow Chart recorders with Total Flow 6610 Electronic Flow computers (EFC) on 23 wells currently approved for operation on one of eight gathering systems and/or central delivery sales meters all operated by Dugan Production Corp. Attachment No. 1 presents a list of the wells along with gathering system and well information for each well.

Each of these wells is currently equipped with a plunger lift or intermitter and produces a paper chart that is difficult to integrate. We are hopeful that the EFC will provide an improved recording of production data and result in a corresponding improved allocation factor. The EFC will continue to use the existing meter run and orifice plate currently installed for the dry flow meter and the EFC will be installed, tested and maintained using BLM's NTL-2008-01.

It is our understanding that the proposed modification to the existing allocation meter will result in a data recording that is at least as good as the current commercially integrated paper chart and does not need formal regulatory approval. If this is not so, we can easily return to using the chart recorder.

Should additional information be needed or specific approvals required, please let me know.
