Pools are included in the NMCD pre-approved pool combinations for DHC in the San Juan Basin. Ownership is not common in both zones; therefore, interest owners were notified by certified mail, return receipt on 5/5/09. Downhole commingling will offer an economical method of production while protecting against reservoir damage, waste of reserves & violation of correlative rights.

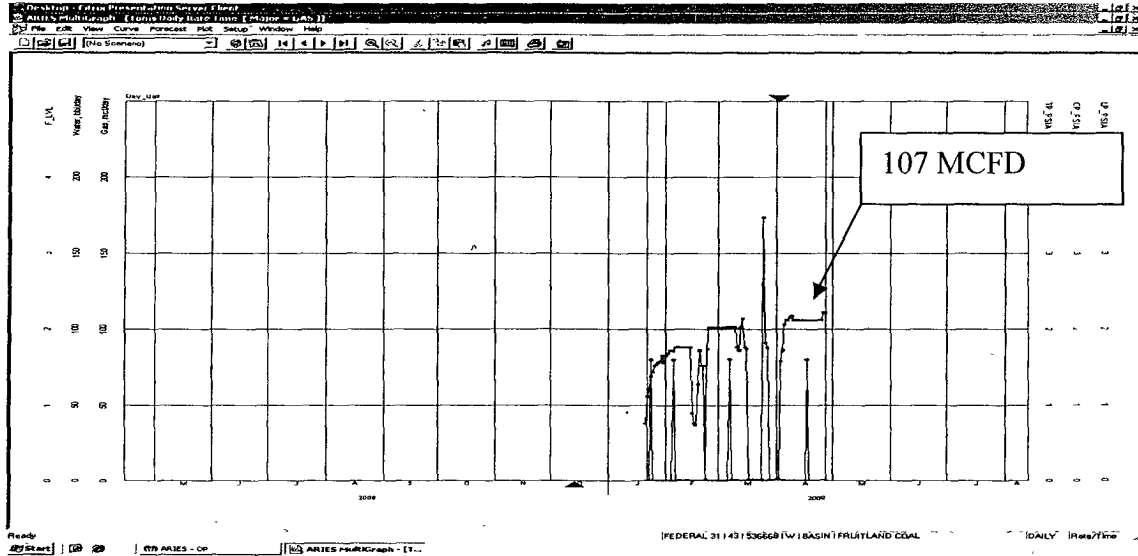
