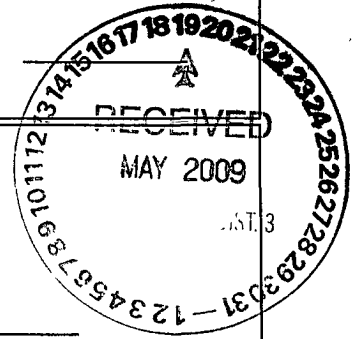

It was determined that the locations be built CLOSED LOOP. We currently have a C144 filed and approved for a Temporary Pit and a Closed Loop.

Construction has built a smaller lined pit (105'x35'x12') to hold the cuttings from the Closed Loop.
