Finley Resources, Inc. requests an extension of the September 30 deadline set forth by the Bureau of Land Management regarding operations to be performed on the San Isidro 16 #010 well and request a new deadline of April 30, 2010 to workover, resume production or plug and abandon the well. This property has been involved in litigation for several months and although the details of that litigation are confidential, Finley Resources, Inc. became operator of the San Isidro 16 #010 well and the San Isidro 16 #8 well effective June 15th, 2009, as depicted on the Sundry notice filed with the BLM. Finley Resources, Inc. needs to evaluate the production and other information regarding the San Isidro 16 #8 before it can determine how best to proceed with the San Isidro 16-10 and therefore request this extension.
