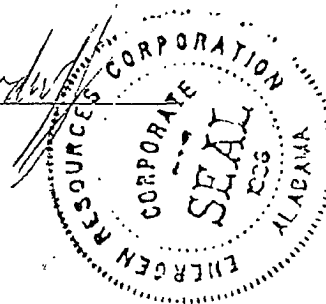

TO THE HONORABLE SECRETARY OF STATE OF THE STATE OF ALABAMA:

Pursuant to the provisions of Article 10 of Chapter 2B of Title 10 of the Code of Alabama of 1975 (§§ 10-2B-10.01 et seq.), the undersigned corporation executes the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Taurus Exploration U.S.A., Inc.

SECOND: Article 1 of the Restated Articles of Incorporation of said corporation is hereby amended as follows:

"The name of the corporation is Energen Resources Corporation."
