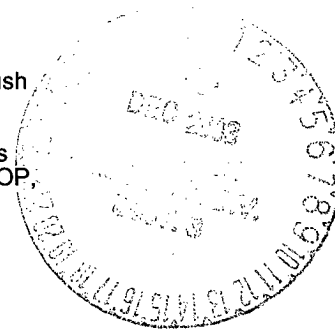

Pumped a preflush of 30 bbls water w/10 bbls dye water ahead of Lead - 425 sx (1109 cf) Class "G", 3% Econo-lite, 0.25#/sx Cello-flake, 0.2% Anti-foam. Tail - 100 sx (127 cf) Class G, 50/50 POZ, 2% Bentonite, 2% CACI2, 0.25#/sx Cello-flake, 5#/sx Gilsonite, 0.2% Antifoam. Dropped plug and displaced w/130 bbls water. Bumped plug w/1250 psi @ 1930 hrs 10/21/03. Circ. 50 bbls good cement to surface. ND BOP, set slips and cut off casing. RD & released rig @ 0400 hrs 10/22/03. Will show casing PT on next report.
