Pumped a preflush of 10 bbls dye water. Pumped 150 sx (201 cf - 35.79 bbl slurry) STD 50/50 POZ, 2% Bentonite, 5#/sx Gilsonite, 0.2% CFR-3, 3% CaCl2, .25#/sx Celloflake. Dropped plug and displaced w/15 bbls water. Bumped plug to 188 psi, plug down at 2034 hrs 12/11/03. Circ. 15 bbls good cement to surface. WOC. NU WH & BOP. PT-OK. PT casing, rams and manifold to 1000 psi for 30 minutes. Good test.
