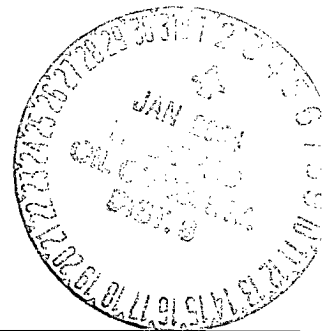

12/6/03 RIH w/6-1/4" bit & D/O cement from 3442' - 3382'. C/O hole from 3382' - 3620 w/Air & mist. Drilled from 3883' - 6263' (TD). TD reached 12/8/03. Circ. hole clean. COOH. RIH w/4-1/2", 10.5#, J-55 ST&C casing and set @ 6263'. RU Halliburton to cement. Pumped a preflush of 20 bbls 2% KCL & 10 bbls water. Pumped 360 sx (522 cf - 92.96 bbl slurry) STD, 50/50 POZ, 3% Bentonite, 0.2% CFR-3, 0.8% HALAD-9, 0.1% HR-5, 5#/sx Pheno-seal. Dropped plug & displaced w/99 bbls 2% KCL. Bumped plug to 1000 psi. Plug down @ 1615 hrs 12/9/03. No cement to surface. Set slips, ND BOP stack & cut off casing. RD & released rig 12/10/03. Will show TOC and casing PT on next report.
