Tail w/52 sx Type III cement + 1 lb/sx Calcium Chloride + 0.25 lb/sx Celloflake + 0.2% BWOC FL-52 + 59% fresh water (14.6 lb/gal, 1.38 cu ft/sx - 72 cu ft total slurry). Circulate 18 bbls cement.
