

Describe Cause of Problem and Remedial Action Taken.\* **On January 11, 2009, a COPC contractor, Dawn Trucking, discovered a produced water spill due to a pit tank overflow allowing produced water to impact the ground within the berm area. Upon discovery, the contractor notified COPC and the water hauler recovered all standing fluid in cribbing & berm.**

Describe Area Affected and Cleanup Action Taken.\* **All of the spilled fluids remained on location. Approximately 165 BBL was recovered and all water was contained in the berm. Dawn Trucking steam-cleaned the area within the bermed area and was able to recover the residue from the spill and disposed of approximately 80 BBL of water & ground-covering at IEI, Inc. landfarm. COPC will monitor the soils after the ground has thawed for environmental impact. To prevent reoccurrence, COPC will continue to monitor pit tank levels.**
