The well was being plugged and had been disconnected from gathering line. Apparently a cow kicked open the valve on the line and oil spilled from the line. Extensive rain in area kept spill on surface. Crude was vacuumed with water truck (7bbls), mopped with absorbent pads, and any contaminated soil will be scraped from surface (estimate 5 Cu. Yds.) and removed to BMG Landfarm. Soil scraping cannot be done until Mr. Gifford Velarde, Jicarilla approved archeologist clears site on Monday, June 15, 2009. Will schedule soil sampling for Wednesday, June 17 or after.

Approximately 10' x 50' area on location and two 2' x 75' areas north of location
