Describe Cause of Problem and Remedial Action Taken.* **On December 22, 2008, a COPC MSO discovered an approximate 27.5 BBL condensate & 23.5 produced water was released on the Nye Federal #3 due to a leak in the production tank possibly from corrosion. Upon discovery, the MSO shut in the well and notified COPC. All spilled fluids remained in the berm. None of the condensate was recoverable.**

Describe Area Affected and Cleanup Action Taken.* **All of the spilled fluids remained on location. The spill impacted soil on the ground surface around the tank. The production tank was removed and approximately 582 yd3 were excavated by M&M Trucking & hauled to IEL land farm. Clean backfill from the Aztec Machine Shop was brought back into the location. Envirotech completed conformation sampling. To prevent reoccurrence, COPC will continue to perform tank inspections.**
