A cavitation rig was rigged up on the subject well to remove the production liner and deepen the well 100' into the PC.

Production liner was removed from the wellbore.

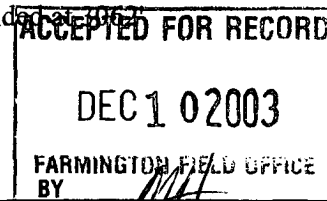
When deepening operations commenced, a fish left in the hole from previous operations was encountered.

Attempts to recover the fish were unsuccessful and deepening operations were abandoned.

Natural and air assisted surges were utilized to remove near wellbore material.

No production liner was run in the well. Tubing (2-7/8") was run in openhole and landed at 8962'

The well was turned to sales producing from the openhole Fruitland Coal.
