BP America Production Company request permission to surface commingle production the Basin Dakota, Blanco Mesaverde, and Blanco Pictured Cliffs Pools from our E E Elliott B Wells No. 3, 9, & 11. Surface commingling Basin Dakota production will consist of the E E Elliott B Well No. 9; Blanco Mesaverde production will be from the E E Elliott B Well No. 3; and Blanco Pictured Cliffs production will be from the E E Elliott B Well No. 11. The production from each well will be metered prior to commingling then the commingled production will flow into through the separator where the liquids will be removed. The commingled gas will then be sent through compression prior to entering the sales meter. Please reference the attached schematics reflecting the Current Facilities Layout and the Proposed Surface Commingling Layout provided for your reference. The working interest, royalty and overriding royalty interest owners in the subject wells are identical. The proposed commingling of production is to reduce operating expenses between the wells and will result in increased economic life of the wells.

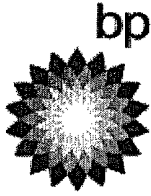

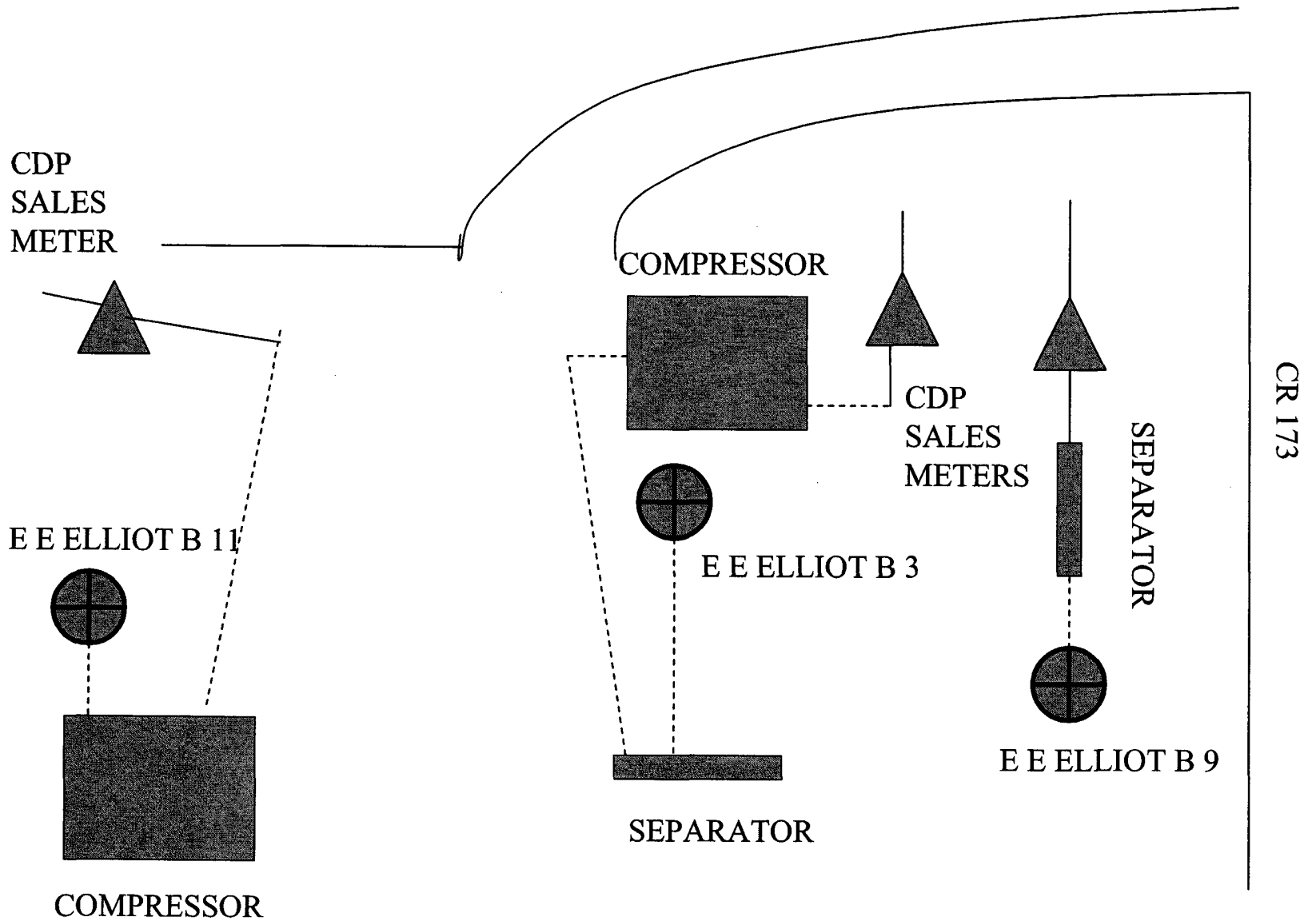
