This well is capable of gas production, but has logged off. On January 4, 2010, field personnel manifolded the casing and tubing together. The well will remain shut in for about a week to see if the casing can build up enough pressure to lift the water in the tubing. If not, we will schedule the well for swabbing operations as weather permits. A sundry will be submitted upon the return of this well to production.
