12/8/03 Set CIBP at 4480. Pressure test casing to 3500 psi-OK. Perforate Cliffhouse/Menefee from 4128-4450' with 35 holes.  
12/9/03 Acidize and ball-out perforations with 2000 gals 15% HCL and 45 bio-balls.  
12/10/03 Frac well with 60Q Foam Slickwater and 130,660# 20/40 sand.  
12/11-12/03 Flow back frac.  
12/13-15/03 TIH Clean out to CIBP @ 4480' with air mist. Drill out CIBP and clean out to PBTB.  
12/16/03 Land tubing @ 4776'. Return to production.
